In KG1-KG2 grades, RIS promotes the Standard Arabic Provision and Emirati Culture through academic, cognitive, play-based, child-centered, mental, physical, social and emotional wellbeing development of Students.

In KG1-KG2, the School complies with the MOE and KHDA guidelines as follows:

- the instructional time per subject:
 - 1) Arabic 200 minutes weekly or 40 minutes daily (5 days per week) in 2025 2026, increasing to 300 minutes weekly (60 minutes daily) by 2027 2028; children must be exposed to Arabic for at least 1/3 of their weekly instructional time;
 - 2) Islamic Studies 90 minutes weekly;
 - 3) Social Studies embedded across subjects within daily educational activities;
- the age-appropriate methodology of teaching, MOE books use, learning resources and linguistic principles implementation;
- the play-based learning, real-life situations context, multi-sensory and hands-on experience; the digital technology monitored use in kindergartens;
- the wellbeing, inclusion and SEN support;
- the learning outcomes, feedback and progress reports;
- the documented evidence of assessment, attainment and progress;
- the national educational policies;
- the Arabic Language integration across the curriculum;
- the Emirati cultural integration and cross-cultural understanding;
- the teacher's professional development (completing a minimum of 20 hours of training annually)
- the induction, observation and performance review by the School Leadership.
