### INTRUSION POLICY

*RIS strives for the crucial security responsibility towards the educational institution.*

#### **Intrusion security:**

It is an integrated security system for detecting safety risks such as intruders, hazards, and internal threats. An intrusion security helps create a safe learning space:

- Protecting staff and students from intruders
- Managing unexpected hazards such as natural disasters, fires, and utility outages
- Evacuating students and staff during emergencies
- Managing access to the school premises
- Preventing crime, theft, vandalism, bullying, etc.

#### **Intrusion security includes:**

##### **Active surveillance**

Round-the-clock surveillance with a sufficient number of security cameras in strategic spots.

##### **Monitored access control**

Controlling access via security systems and monitoring the gates access to school premises.

##### **Access permission:**

- Granted permission to enter the school premises by the staff and students via their access security cards
- Services companies, contractors, parents gain access upon prior appointment via the dedicated channels of communication.

##### **Glass break monitoring**

A glass break control sits in the first line of defense against intrusion.

##### **Alarm sequence monitoring**

What happens when a specific alarm is fired? A dispatch response includes the update from the Police Quarters, Civil Defense. It is essential to record all the alert events, even the false alerts.

##### **The school embraces proactive security measures:**

- Surveillance Cameras
- Security Guard
- Health and Safety Committee.

Security camera's recordings are to support School safety (recorded video will be stored for an appointed period of time).

Personnel are prohibited from using information acquired from the school security cameras, except for official purposes. All information and/or observations are considered confidential and can only be used for official school and law enforcement purposes.

**Safeguarding Objectives:**

1. Care, welfare and safeguarding of students, including child protection.
2. Arrangements to ensure health, safety and security.
3. Quality of record keeping.
4. Suitability of premises and facilities for all the students.
5. Provision for and promotion of safe and healthy lifestyles.
6. Staff-student relationships and emergency response behavior management.
